# Projek naik taraf jalan jimat masa, beri keselesaan masa, beri kes

Kuala Selangor: Projek menaik taraf Jalan Persekutuan FT54 dari Sungai Buloh ke Assam Jawa, di sini, memberi kelegaan kepada penduduk setempat, selain meningkatkan mutu perhubungan di beberapa daerah.

Penduduk, Samsol Buyong, 70, berkata, pelebaran dan kerja naik taraf jalan yang dimulakan sejak empat tahun lalu itu dilihat mampu menjimatkan masa penduduk dan memberi keselesaan ke-

pada pengguna.

"Sebelum ini, jalan hanya satu lorong dan kerap berlaku kesesakan serta kemalangan, terutama pada musim perayaan, tetapi dengan adanya pelebaran dan naik taraf ini, ia memudahkan penduduk bergerak dari satu tempat ke tempat lain dengan mudah, selain keadaan jalan berturap dan lebih selesa," katanya yang menetap di Assam Jawa sejak 33 tahun lalu.

Katanya, meskipun jalan dinaik taraf, dia berharap pengguna jalan raya mematuhi peraturan, selain peka dan prihatin dengan keadaan sekitar.

"Kebanyakan rumah penduduk terletak di tepi jalan. Saya harap pemandu mengikut had laju ditetapkan dan tidak menyalahgunakan kemudahan

disediakan," katanya.

Berlainan pula dengan Muhammad Syahmi Syafiq Badron, 26, projek itu serba sedikit menyukarkan sebilangan penduduk yang menggunakan pengangkutan awam seperti bas untuk ke tempat kerja atau kawasan berhampi-

"Sebelum projek bermula, penduduk mudah melintas ke seberang jalan, tetapi, bila projek siap, penduduk terpaksa mencari alternatif lain bagaimana hendak menaiki bas.

"Tambahan pula, penduduk takut melihat segelintir pengguna jalan raya yang seakan-akan tidak peduli dengan kawasan sekitar apabila membawa kenderaan dengan laju," katanya.

Tambahnya, dia meluahkan rasa bersyukur dan berterima kasih kepada pihak berwajib yang memasang lampu isyarat di setiap persimpangan sepanjang laluan itu.

"Apabila lampu isyarat dipasang, perjalanan jadi lebih teratur," katanya.

Sementara itu, Menteri Kanan Kerja Raya, Datuk Seri Fadilah Yusof, berkata projek menaik taraf jalan itu dijangka akan siap sepenuhnya pada November ini dan jauh lebih awal daripada dijadualkan.

Beliau berkata, selain dapat disiapkan awal, projek membabitkan laluan sepanjang 25 kilometer itu berjaya mencatatkan penjimatan kos kira-kira sebanyak RM10 juta. **BH**

She confirmed that MPK COB had received more than 10 written complaints on the issue. William said politicians, non-gov-

ernmental organisations and MPK officers had been visiting residents since 2008, had taken note of the

problem and made promises but nothing had happened so far. He said there were a total of 200 units in the two blocks but only an estimated 70 units are occupied.

"More people had moved out over the years as they feared the building

"But there are still many who stayed back and are forced to live under such circumstances because we are too poor and unable to get alternative housing," he said.

He complained that there was wastewater pouring out on the grounds and suspected that

the sewage pipes and tanks had sunk

He added that at times, an overpowering stench permeated the area.

William hoped this time, something would be done to fix the soil sinking problem once and for all.

Housewife Normala Mohamad, 40, said other than the soil settlement issue, there were several abandoned units on the top floor as a storm had blown off the roof above these units.

"We hope the Selangor government will approve the allocation to remedy the soil settlement, repair the roof and electrical wiring as well as give both blocks a fresh coat of paint," Normala said.

Another resident, Ahmad Arif, 32, said soil settlement had left the building sitting on concrete slabs

"We believe the slabs are now holding up the buildings," he said.

Klang JKR district engineer Syaharidanisman Mohd Johanis said many buildings along Selangor's coast suffered similar issues as they were built on marine soil like the TTGI flats.

"If the foundation is not stabilised, eventually the structural integrity of the building will be compromised.

"I believe a possible method to address the problem is to inject cementitious grout into the weak marine clay beneath the foundation," he said.

Syaharidanisman said Klang JKR should be able to submit the bill of quantities to MPK next month, including specific remedial work methods together with technical drawings as well as the tender documentation that would specify the cost of the project, so that MPK would be able to source for sufficient allocation.

He added that tender documentation would include the total rectification works for both blocks including new roofing, ceiling, electrical wiring, scupper drains, wider drainage, paintwork and repairs to broken sewage tanks and pipes.



Normala hopes the state government will do something to make the flats safe and habitable.

## 'Burger stall operators were warned'

#### Shah Alam council defends itself against videos alleging selective enforcement w/s-3

SHAH Alam City Council (MBSA) is defending itself following viral videos accusing officers of penalising two stalls in Bandar Baru Sungai Buloh without taking action against others

The person who filmed the two videos, claimed that two burger operators had their stalls confiscated by MBSA enforcement officers.

MBSA Corporate Communications head Shahrin Ahmad said the burger stalls and items were confiscated because the operators had failed to remove them after business hours. "We had already advised them not to leave their belongings by the roadside as it was dangerous and an obstruction to road users," he explained.

The two videos also alleged that other stalls were involved in illegal activities.

The videos, which were six and 13 minutes long respectively, showed footage of roadside stalls allegedly run by foreigners selling cigarettes and of illegal gambling activities at a premises nearby.

"Next to the burger stall is one run by foreigners."On the stall front, it would look like they are selling fruits and drinks, but they have actually been selling contraband cigarettes for years," he claimed in the video, adding that these stalls were not checked nor ordered to close.

The person also questioned the need to confiscate the burger stall when other food stalls along the same row were not penalised.

In the video, some stalls were seen set up on parking bays while others were by the roadside or on a payement.

"Why is MBSA only disturbing youths selling burgers and not taking action against other stalls in the vicinity?

"There are stalls selling clothes by the roadside while some are occupying parking bays, but no action was taken," he added.

The person also claimed that the burger stall operators had adhered to recovery movement control order rules.

"The burger stalls followed the operating hours given and I have visual proof of other stalls operating past midnight.

past midnight.

"Where was enforcement then?"
the person questioned.

Shahrin said MBSA enforcement officers had warned the burger stall operators twice over the last two months before seizing their items.

"Despite the warnings, they did not remove the stalls after completing business

ing business.

"Also during the recovery movement control order, they were found to be operating beyond midnight, which is not allowed," he pointed out.

He also highlighted that during the latest operation over the weekend, MBSA officers had shut a stall selling cigarettes and seized items.

As for the premises believed to
be running gambling activities,
Shahrin said MBSA would work
with the police.

"If the allegations are true, necessary action will be taken," he added

#### Flood mitigation work at Sg Buloh new village to start next year M/5-3

KAMPUNG Baru Sungai Buloh

KAMPUNG Baru Sungai Buloh residents flood woes are expected to end by next year with the plan to upgrade the entire drainage system there.

Selangor local government, public transport and new village development committee chairman Ng Sze Han said the Public Works Department (JKR) would begin the large-scale project next year in stages to resolve flash floods in the area.

stages to resolve hash mode in the area.
"The drainage system in this area has created a lot of prob-lems, as it has not been upgraded for many years, with many drains clogged," he said.
Residents have complained of floods in the area due to bad drainage.

drainage.

Ng visited the construction site

of a partially collapsed drain under repair along Jalan Industri 9 at Kampung Baru Sungai Buloh. Work on the 100m-long drain,

work on the 100H-101g train, including widening and reinforcing the walls, cleaning works, repairs to the feeding pipes and road widening began in July and is expected to be completed by the end of the month.

The state allocated RM800,000

for the repairs on the drain as well as the drainage system to combat floods.

Ng said it was a challenge to conduct upgrading works as the area was an unorganised heavy industrial zone with an unsystematic network of drains.

During the site visit, he was accompanied by Kota Damansara assemblyman Shatiri Mansor, JKR engineer Ilias Abdullah, Kampung Baru Sungai Buloh village head

Baru Sungai Buloh village head Hoo Sook Wan, village communi-

cations officer Tony Cheong and several Kampung Baru Sungai Buloh residents. Illias said JKR would conduct

extensive checks on critical flood zones within Kampung Baru Sungai Buloh and upgrade as many drains as possible over the

next year.
Hoo said flooding had occurred in the area for 15 to 20 years and was grateful that JKR was taking

action to fix the problem. Nearby roads such as Jalan Welfare, Jalan Baru Sungai Buloh and Jalan Industri 10 were also

frequently flooded.

She recalled the worst floods on Nov 15, 2018, where the entire area was under water, damaging factories and homes.

There were even incidents of vehicles being swept away," said

WITH rapid development and destruction of trees in several Petaling Jaya neighbourhoods, residents have revived a community watch to monitor the Petaling Jaya City Council and raise their concerns collectively.

Calling themselves "MBPJ Watch," the social media group that was formed in 2018 for residents to respond to mega projects in Section 13 that they claimed impacted their quality of life.

The group was revived recently to act as a watchdog and had brought to light the destruction of trees along Jalan Universiti, Jalan 17/21 as well as other environmental issues.

Section 17 resident Tracy Toh, in a post, said the residents needed to band together to show MBPJ that it was not only one or two residents who objected to the felling of trees.

She said many trees had been chopped down in various areas of Petaling Jaya over the years.

However, several residents' report of nine trees having been cut down along Jalan Universiti on Aug 2 was found to be false.

MBPJ Zon 11 councillor Thayalan Krishnasamy confirmed that no more trees were felled since the end of July.

"I think people were quite sensitive to reports of tree cutting as there has been some questionable council action with nearby residents hearing chainsaw noises throughout the night, so there was some unfortunate jumping to conclusions," said Soon. She added that it was likely the

### Kes sudah diambil tindakan: Jais m/s- 5

Kuala Lumpur: Ajaran sesat baharu yang tular di media sosial kelmarin adalah kes lama yang berlaku pada 2016 dan 2018 serta sudah diambil tindakan oleh Jabatan Agama Islam Selangor (Jais).

Pengarahnya, Mohd Shahzihan Ahmad berkata, ia adalah acara yang dianjurkan sebuah badan bukan kerajaan (NGO) yang menyediakan rumah perlindungan bagi semua peringkat umur terutama kanak-kanak.

Katanya, NGO itu sering mengadakan program berbentuk kerohanian untuk ahlinya, selain terbuka kepada orang ramai yang berminat.

"Pada 14 Disember 2016,

Bahagian Penguatkuasaan Jais memantau acara Pure Life Society bertajuk Spiritual Musical Night di Dewan Sivik, Petaling Jaya yang dihadiri pelbagai kaum, peringkat umur dan agama.

"Acara itu dilihat menggabungkan tujuh agama atau pegangan yang berada di Malaysia iaitu Islam, Kristian, Buddha, Hindu, Sikh, Bahai dan masyarakat Orang Asli.

"Sepanjang pemerhatian di lokasi memperlihatkan acara itu cuba membawa konsep plurality iaitu menggabung atau menyamaratakan semua agama dan pegangan di bawah satu pemikiran atau pegangan yang

baharu," katanya.

Mohd Shahzihan berkata, kes berkenaan disiasat di bawah Seksyen 7 Enakmen Jenayah Syariah Selangor 1995 berkaitan doktrin palsu.

Katanya, masyarakat Islam diminta menyalurkan maklumat kepada Jais sekiranya mendapati ada perkara atau aktiviti tentang agama Islam atau mengenai agama Islam yang bersifat eksklusif.

"Islam sifatnya inklusif, terbuka dan telus. Suatu yang bersifat selektif dan pelik mesti dimaklumkan kepada pihak berkuasa. Tiada cara mudah dalam Islam, semuanya mesti berdasarkan ilmu pengetahuan yang benar dari guru yang diiktiraf oleh Jais," katanya.

Kelmarin tular di media sosial menerusi Facebook We Are All Firdaus Wong yang mendedahkan wujud sebuah kuil beralamat di Puchong dikatakan menjadi lokasi penganut ajaran agama itu berkumpul.

Ia menimbulkan persoalan banyak pihak yang mempersoalkan tindakan pihak berkuasa agama dalam menangani isu berkenaan

Dalam perkembangan sama, Jabatan Agama Islam Wilayah Persekutuan (Jawi) akan menjalankan siasatan berhubung isu berkenaan.
