'Loji IWK bukan punca air Sungai Gong jadi hitam'

Syarikat kenal pasti ada bahan buangan sisa haram sebabkan pencemaran

Kuala Lumpur: Syarikat pembetungan dan pengurusan sisa kumbahan, Indah Water Konsortium Sdn Bhd (IWK) semalam, menegaskan kejadian air di Sungai Gong, Rawang menjadi hitam, bukan berpunca daripada pelepasan effluent Loji Rawatan Kumbahan Kawasan Perindustrian Rawang (GBK134) seperti dilaporkan media, kelmarin.

Ketua Pegawai Eksekutif IWK, M Narendran, berkata pihaknya sudah mengenal pasti ada buangan bukan kumbahan berwarna kuning dalam kebuk masuk loji itu sehingga menyebabkan effluent di peringkat proses akhir loji tercemar dengan warna kuning pekat.

"Petugas IWK di loji terbabit masih memantau dan mengawal dengan pantas bagi mengawal keadaan," katanya dalam kenyataan semalam.

Kelmarin, media melaporkan Lembaga Urus Air Selangor (LUAS) menerima laporan insiden air Sungai Gong, Rawang berwarna hitam, tetapi tiada bau yang disyaki disebabkan pewarna.

Hasil siasatan lanjut, LUAS menemui pelepasan effluent berwarna dan berbulih, daripada discay effluent loji rawatan kumbahan IWK GBK 134 area 5, di kawasan Perindustrian Rawang.

Kesal dengan dakaawan itu, Narendran berkata perkara itu boleh mengelirukan orang ramai, selain menjadi penyebab mereka menudung jari kepada IWK, walaupun punca sebenarnya berkenaan daripada pembuangan sisa secara haram.

"IWK sangat kecewa kerana seiring menjadi sasaran mudah kepada sebarang kejadian pencemaran air seperti kejadian terburu ini tanpa membuat sebarang periksaan rapi atau melaporkan maklumat secara menyeluruh," katanya.

Mengulas lanjut, beliau memaklumkan bahawa loji rawatan air kumbahan direka bentuk hanya bagi merawat air kumbahan dan ia tidak mampu merawat sebarang bahan kimia atau sisa lain yang dilepaskan secara haram ke dalam jajaran paip pembentungan.

Tegasnya, pembuangan sisa haram bukan kumbahan adalah satu kesalahan di bawah Akta Industri Perkhidmatan Air 2006.

Air pasang besar jejas Klang, Sabak Bernam

Fenomena masuk hari kedua punca haksiran teruk berlaku pada benteng pantai

Klang. Beberapa kawasan di sekitar daerah Klang dan Sabak Bernam semalam, terjejas ekoran fenomena air laut pasang besar yang melanda kawasan itu.

Ketua Unit Pengurusan Bencana Selangor, Ahmad Faizur Mohd Yusof, berkata sehingga jam 11.30 pagi semalam, ia masih belum ada maklumat mengenai jumlah pantai yang terjejas akibat fenomena air laut pasang besar yang melanda Klang.

Sekitar lima belas berkata, jeti pangkalan nelayan Kampung Delek, Jalan Banting Pandemaran, pangkalan nelayan Sungai Rengit, Kampung Baru Telok Gong dan kampung tradisi serta Kampung Penduduk di sini.

"Tiga rumah di dalam Kampung Peraduan dinikati air akibat lumpuhnya sistem sumur air mulai semalam secara bersama-sama."

"Ban dan benteng di pusir pan tau juga kukuh dan dalam keadaan baik. Saya masih selamat dan terkejut." katanya.

Menurut Ahmad, jumlah kawasan yang terjejas akibat fenomena air laut pasang besar yang melanda Klang semalam mencapai 50

dan 55 saut itu, kehilatan puluhan pengguna jalan raya memberhentikan aktiviti mereka. Ia turut menyebabkan air melimpah di kedua-dua laluan. Ada juga pengguna yang dilahir berani melalui jalur itu terutama kenderaan pacuan empat roda.

Berengkuang Kampung Tok Muda di Kapar turut mengalami limpahan air akibat fenomena air pasang besar.

Selain itu, fenomena air laut pasang besar yang memasuki hari kedua merupakan sebuah perkembangan yang tidak biasa bagi Selangor.

Sejak November 2018, Selangor

JPS diminta sedia peruntukan khas baiki jalan rosak

Tanjong Karang: Ahli Parlimen Tanjung Karang, Tan Sri Noh Omar, berkata pihaknya sudah meminta Jabatan Pengairan dan Saliran (JPS) menyediakan peruntukan khas untuk kerja membaik pulih beberapa jalan yang rosak di sepanjang Sungai Kajang. Beliau berkata, hasil pemantauan dilakukan mendapati Jalan Bagian Sungai Kajang antara yang mengalami kesan hakisan teruk ekoran dipukul ombak.

Katanya, perkara itu harus diatis bagi memastikan penduduk tidak terputus hubungan akibat kerosakan jalan yang serius.

"Sudah tentu hakisan ombak mengakibatkan jalan rosak dan memberi kesan kepada rumah nelayan yang ada di sekitarnya yang ke-

banyakannya dibina di kawasan ini.

"Kita turut bimbang sekiranya benteng pecah, air laut akan melimpah masuk ke kebun yang boleh menyebabkan hasil pertanian dan ternakan penduduk terjejas," katanya mengulas fenomena air laut pasang besar yang melanda Parlimen itu, semalam.

Noh berkata, beliau turut mencadangkan JPS membina batu konkrit di sepanjang Pantai Sungai Kajang yang ketika ini menjadi tumpuan pengunjung pada waktu petang terutama hujung minggu.

"Sebelum ini, kita pernah meletakkan batu konkrit di pesisir pantai dan berharap ia dapat ditambah lagi bagi menghalang hakisan ombak," katanya.

SHAH ALAM: Indah Water Konsortium Sdn. Bhd. (IWK) menafikan kejadian air hitam di Sungai Gong, Rawang berpunca daripada pelepasan air buangan atau elfuen Loji Rawatan Kumbahan Rawang Integrated Industrial Park (GBK134) miliki mereka.

Malah, IWK dalam kenyataannya turut menyatakan rasa kecewa dengan tuduhan tersebut dan tindakan itu hanya mengelirukan orang awam berikutnya punca sebenar kejadian mungkin disebabkan pembuangan sisa secara haram.

Ketua Pegawai Eksekutif (IWK), Narendran Maniam berkata, loji rawatan air kumbahan hanya di reka bentuk untuk merawat air kumbahan sahaja dan tidak mampu merawat bahan kimia atau sisa lain yang dilepaskan secara haram ke dalam jajadan paip pembentungan.

"IWK kecewa kerana sering menjadi sasaran mudah kepada sebarang kejadian pencemaran air seperti kejadian ini tanpa membuat pemeriksaan rapi atau melaporkan maklumat secara menyeluruh.

"Kita sentiasa memastikan kerja-kerja operasi dan penyelenggaraan di semua 7,000 buah

loji di bawah selian IWK sentiasa mengikut spesifikasi serta prosedur yang telah ditetapkan pihak

berkuasa.

"Pembuangan sisa haram bukan kumbahan adalah satu ke-

salahan menurut Akta Industri Perkhidmatan Air 2006 (WSIA 2006)," katanya dalam satu kenyataan di sini semalam.

Mengulas lanjut, Narendran berkata, petugasnya telah mengenal pasti kemasukan buangan bukan kumbahan berwarna kuning ke dalam kebuk masuk loji yang mengakibatkan effluent di peringkat proses akhir tercemar.

Menurut beliau, pihaknya mengesyaki terdapat pembuangan sisa secara haram yang berlaku berdekatan dengan loji sehingga bahan tersebut dapat mengalir masuk ke dalam loji. "Petugas IWK terus menghentikan pelepasan disaj effluent dan operasi pembersihan segera dilaksanakan dan akan siap sepenuhnya hari ini (semalam).

"Kerja-kerja dos bahan kimia telah dijalankan dengan pantas bagi mengawal keadaan. Petugas IWK masih memantau dan mengawal kemasukan air kumbahan ke loji tersebut.

"Loji tersebut merupakan Oxidation Ditch (OD) Plant yang bersambung kepada 11,106 penduduk setara yang hanya meliputi kawasan perindustrian," ujarnya.

Semalam, Lembaga Urus Air Selangor (LUAS) menerima laporan daripada Jabatan Pengairan

dan Saliran (JPS) Gombak berhubung insiden air Sungai Gong berwarna hitam.

LUAS dalam kenyataannya berkata, siasatan di kawasan Inlet Kolam Tebatan Banjir JPS mendapati air sungai tersebut berwarna hitam dan tiada bau selain disyaki ia disebabkan oleh pewarna.

Berikut itu, katanya, LUAS mengaktifkan Kod Kuning berdasarkan Manual Kecemasan Pencemaran Sumber Air bagi siasatan secara menyeluruh di kawasan terlibat yang berisiko menyebabkan henti tugas Loji Pembersihan Air (LPA) utama di bahagian hilir Sungai Selangor.

Siasatan juga mendapat terhadap pelepasan effluent berwarna dan berbuuh daripada disaj effluent loji rawatan kumbahan Indah Water Konsortium (IWK) GBK 134 area 5 di kawasan Perindustrian Rawang.

Malah, pensampelan telah dijalankan oleh pihak LUAS dan mendapat kandungan Ammonia adalah sebanyak 5.2 mg/l dan TSS adalah 47 mg/l.

Bagaimanapun, kerja-kerja pembersihan di Loji Pembersihan Air (LPA) utama di bahagian hilir Sungai Selangor ekoran air berwarna hitam di Sungai Gong, Rawang dekat sini selesai dijalankan pukul 9 malam kelmarin.

HUKUMAN buntinya keras, tetapi jika itu saja cara untuk mendidik rakyat Malaysia supaya mencintai khazanah bumi, apa salahnya ia diukutuasakan.

Berembun di Jelebu, Negeri Sembilan. Malangnya kami disajikan dengan panorama yang kurang indah di Gua Kambing iaitu satu daripada pusat pemeriksaan atau *checkpoint* sebelum ke puncak. Selonggok plastik, bekas makanan, botol air kosong dan sisa sampah lain terbiar di atas pelantar di tepi batu besar di situ yang sangatlah mencacaikan pemandangan. Ada lagi terselit di tepi batu.

Terfikir juga sama ada si pelaku yang meninggalkan sisa itu langsung tiada rasa bersalah kerana mengotorkan hutan

ada 15 September lalu, Mahkamah Sesyen Selangor dekat Kuala Lumpur membuat keputusan tegas apabila tidak membenarkan empat ahli lembaga pengarah dan seorang pengurus syarikat membaki jentera berat, diikat jamin. Mereka berdepan dua pertuduhan berkaitan pembuangan bahan berbahaya ke dalam Sungai Gong, Rawang yang menyebabkan empat Loji Rawatan Air (LRA) milik Air Selangor Sdn Bhd dihenti fungsi pada 3 September.

Berikut tindakan tidak bertanggungjawab itu, jutaan pengguna di 1,292 kawasan di tujuh wilayah di Lembah Klang menghadapi gangguan air selama seminggu. Ikti hati memang wajar si pelaku yang pentinggok diri dan hanya tahu mengayakayakan syarikat sendiri dihantui terus ke Penjara Bentong sementara menunggu tarikh perbicaraan supaya mereka diperkenan sasaran pencemarkan alam sekitar yang bukanlah kesalahan ringan, apakah lagi jika sudah menganggu kehidupan masyarakat keseluruhannya.

Itu kes terkini yang menjadi perhatian rakyat Malaysia, belum lagi terdahulu kes pencemaran yang tidak dide dahakan, dipandang sepi dan dianggap kurang serius seperti pencemaran hutan.

Saya bangkitkan isu ini kerana sedih dengan sikap orang kita yang tidak pandai menghargai alam sekitar. Anda mahu sihat dan merasai suasana alam dengan mendaki gunung yang kebanyakannya berada dalam kawasan Hutan Simpan Kekal (HSK). Malangnya, ada yang bersikap jelek dengan membuang sampah sesuka hati.

Adakah anda fikir ada pekerja pembersihan atau majlis perbandaran yang akan kutip sampah yang anda tinggalkan itu? Seorang pendaki yang sudah saya anggap seperti kakak lingkungan 50-an menyuarakan rasa kesal dengan sikap manusia pelik sebegini. Dia bukan sebarang pendaki kerana sudah 'berkawan' dengan hutan dan alam semula jadi sejak beberapa tahun lalu, malah hampir setiap minggu mendaki mana-mana bukit atau gunung yang berkenan di hati.

Pada 12 September lalu, kami bersama mendaki Gunung

Tahukah anda bahawa Akta Perhutanan Negara 1984/(Pindaan) 1993 memperuntukkan Seksyen 83 untuk kesalan membuang sampah-sarap secara menganggu dalam HSK. Bermakna pembuangan sampah haram di hutan boleh dihukum denda tidak melebihi RM10,000 atau penjara tidak melebihi tiga tahun atau kedua-duanya.

Jika, ada bukti, boleh kita dakwa pencemar hutan ini seperti dakwaan ke atas wakil syarikat yang dituduh mencemarkan Sungai Gong. Hukuman buntinya keras, tetapi jika itu saja cara untuk mendidik rakyat Malaysia supaya mencintai khazanah bumi, apa salahnya ia diukutuasakan.

Takkun kita mahu hanyut dalam mentaliti kelas ketiga yang kurang kesedaran sivik dan tiada amalan nilai murni. Sudah masanya kita hayati tanggungjawab sebenar sebagai rakyat Malaysia. Menjaga negara bukan hanya memelihara kedaumatannya, tetapi menjadi warga negara yang bersopan santun dan bersusila antara masyarakat serta khazanah seisinya. Jadilah juga hambo Allah SWT yang dilantik sebagai Khalifah di muka bumi bukan untuk mengutamakan ketuanan dan kekuasaan sebaliknya, mengabdikan diri kepada Yang Esa serta berbuat kebaikan kepada seluruh makhluk bumi.

Diskaun

Mohd Azizi berkata, pelanggan ditawarkan diskaun sehingga 20 peratus atau RM150,000 menerusi Program 48 Jam Mesti Beli@Antara Gapi.

Menurutnya, program yang memasuki edisi kelima sejak dianjurkan November tahun lalu itu melibatkan tiga projek perumahan. Antara Gapi dengan 354 unit tersedia bagi rumah link dua tingkat (Widuri), rumah berkembar dua tingkat (Azhara) dan rumah berkembar (Cassia).

Sementara itu, Mohd Azizi berkata, PKNS berjaya meraih nilai jualan sebanyak RM18,691,600 bermula di Kota Puteri pada 2 dan 3 November 2019 (RM5,621,000), diikuti Antara Gapi pada 22 dan 23 Februari 2020 (RM4,489,000), jualan secara atas talian pada 20 hingga

21 Jun 2020 dan Bernam Jaya pada 18 dan 19 Julai 2020 (RM6,381,600).

Justeru katanya, pihaknya mensasarkan nilai jualan sebanyak RM4 juta bagi program yang akan berlangsung hujung bulan ini selain menyediakan pelbagai lagi taruhan menarik pada jualan penghujung tahun ini.

THE smell of noxious fumes emanating from a drain in a housing has raised the ire of residents at Bandar Kinrara in Puchong.

When met by *StarMetro*, several senior citizens said the odour was so strong, it triggered dizzy spells, headaches and nausea among a few of them.

Resident Wong Chan Ying said she detected an unusual smell from her kitchen at Mayang Apartment in Jalan BK 3/1 last week.

"The smell was similar to insecticide solution from mosquito fogging but I thought nothing of it then," said Wong.

Another resident, Ramesh Vadivelu, said he caught a whiff of the fumes while standing in front of his house in Jalan BK3/10A last week.

"It was like the smell of diesel," said the automobile workshop owner.

The smell was also reported by a morning exercise group at a playground in Jalan BK3/1.

Residents Chong Kwai Chee, Shireen Ho, Choong Sai Moi and Hon Moi Ngong said, like Wong, they thought the smell was due to a fogging exercise until someone pointed out that fogging would not be conducted so early in the morning.

At SK Section 2 Bandar Kinrara, security guard Ramadas Marudeviren said he too, detected a diesel-like smell coming from the drain in front of the school at around 7am as parents dropped pupils off at the main gate.

Prompted by curiosity, Hon, the leader of the morning exercise group, followed the odour and traced it to a monsoon drain that ran through the housing area.

"This drain runs all the way to Jalan BK3/2 where the playground is located, through the backlanes of Jalan BK3/10 and along Jalan BK 3/3B, which is just next to the Puchong-Sungai Besi Highway. At Jalan BK3/8 where the primary school is located, we saw oil-like patches in some parts of the drain," said Hon.

By evening, the odour could no longer be detected but the incident

Foul odour riles up Puchong residents

They suspect smell caused by chemical discharge into nearby monsoon drain

had raised the alarm among residents who suspected the fumes could have come from chemical waste being illegally dumped in an unidentified location near the housing area.

Subang MCA division chairman Lawrence Chiew said this was not the first time there was effluent discharge in the housing area's drains.

"Some years ago, when a fire broke out at a factory located in Kinrara Industrial Park opposite the Bandar Kinrara housing area, an unidentified liquid travelled from there to the drains here. This liquid produced huge bubbles which floated out from the drains into the surroundings and stuck to vehicles. There was also a strange

smell from this liquid," said Chiew. Residents also deduced that the drainage system between the industrial park and housing area was connected, which might explain how the leakage from the factory fire several years ago reached the housing area.

Following the recent episode, residents are suspecting that the drain connection may have played a role.

Residents who went to the industrial park said they saw a newly set-up construction site where two large tanks, believed to contain diesel or engine oil, placed beside a drain near Jalan TPK 2/2.

There were large patches of spillage on the road surface and on a grassy area where a make-

shift workers' dorm had been set up. In the drain was blackish water.

When contacted, Matthew Koh, a project engineer at Great Tunnel, the subcontractor in charge of the site, said the diesel tanks were placed there to supply fuel to power the machinery for a drainage construction project.

Refuting allegations of dumping, Koh explained that on Sept 14, a valve in one of the tanks had malfunctioned, causing diesel to spill out in the late evening. The malfunction was only discovered the next day.

Koh said as soon as he was alerted of the situation by the site manager, a water tanker was sent to the site to flush the drain.

Chiew said the smell had dissipated and residents were no longer bothered by any more unpleasant odours. However, he reiterated the seriousness of the issue, citing the recent unscheduled water cut which had affected 1,200 areas in the Klang Valley as an example of the far-reaching consequences of pollution.

"Construction sites as well as factories must really look after the storage of flammable and toxic liquids like diesel or gasoline to avoid leaking for the sake of public health and safety," said Chiew.

When contacted, state local government, public transport and new village development committee chairman Ng Sze Han said the complaints by residents would be looked into.

"This is unacceptable. I will get MPSJ's enforcement team to check on this," said Ng who is also Kinrara assemblyman.

Public urged to take legal action over water cut

YUK Suh Pong, 52, thought death was at the door as he was unable to undergo his scheduled dialysis at a charitable centre during the recent water cut which impacted 1.2 million Klang Valley households.

"I was in pain and I was almost certain that I was going to die. This water cut is not something that people like me can take lightly."

"We can die due to our condition if we miss our dialysis cycle," said Yuk who has been undergoing dialysis for the past five years.

Understanding the predicament of thousands like Yuk and small business traders, Wangsa Maju assemblyman Datin Paduka Dr Tan Yee Kew formed a legal team to sue the relevant agencies in charge of protecting clean water source.

She invited the public outraged by the recent water cut caused by the Sungai Gong pollution to file their case with several legal firms she had engaged for a fee of only RM20.

"Usually, the public will shy away from taking up cases against the authorities because it is expensive to engage in lawsuits besides being time consuming."

"It is high time the public demand the authorities entrusted to protect the people's rights to clean and uninterrupted supply of water to discharge their duties properly," she said.

Dr Tan said it was always those living in flats with no lifts or faulty lifts as well as patients, the elderly, and single parents who suffered immensely.

She said the legal team consisted of law firms, law professors and lawyers who would build a strong case with help from the public.

The team hopes to file a suit within two months and is urging the public to come forward with their cases.

Dr Tan highlighted the various important roles played by different agencies which her team plans to sue.

She said the Department of Environment had the power under the Environmental Quality Act 1974 to prohibit, prevent and control pollution of rivers and other inland water.

The National Water Service Commission (SPAN) is responsible for the implementation and enforcement of water supply services laws, ensuring the productivity of water supply industry and the monitoring and regulating of operators' compliance with the stipulated standards, under the Water Services Industry Act 2006.

Meanwhile the Lembaga Urus Air Selangor (Luas) is responsible for managing water sources under the Lembaga Urus Air Selangor Enactment 1999.

Among its responsibilities are to control water-source usage to avoid any disruption to the natural flow of water in any water source, grant licences to undertake any activity related to water sources and to regulate the licensees and their activities, as well as protect the interest of consumers of water in relation to quality and the prices to be charged for water supply.

Meanwhile Air Selangor is the sole licence holder of water supply services in Selangor and Kuala Lumpur.

"This legal team will fight to claim for losses suffered by the public and business. If 1% of the 1.2 million households come forward, we will have a strong case.

"Money is not the main issue here but we want the agencies with power and responsibility to ensure no disruption of clean water supply to the public," said Dr Tan at a press conference held at her office.

She said there had been about seven water cuts in the past 14

months and this had resulted in agony and losses among the public.

"Often, when a water cut takes place, the authorities will charge the company or individuals at the court and the issue will die."

However, there are key government agencies and companies vested with the power to protect these resources.

"Have these government departments and agencies exercised the powers in which they were established under the various Acts and have they discharged their duties diligently as the Acts intended them to be?"

"Malaysians are kind and gentle people but we must have the courage to challenge the agencies if needed," added Dr Tan.


ENUMERATORS, involved in the Malaysian Population and Housing Census 2020, for Klang District, will visit households where the occupants will be asked to answer questions that will influence the Government's planning and policies for the next decade.

Klang Municipal Council (MPC) president Dr Ahmad Fadzli Ahmad Tajuddin said a few hundred enumerators would knock on doors of households in the district with the

aim to get a complete and accurate count of the population along with other important information.

"This exercise is crucial for the Government as the census data can be used to determine housing issues, where government funding should go or how to allocate for important projects and services that will benefit locals in a district," he said after meeting with the appointed enumerators for the census.

Fadzli, who has been appointed as Klang District Census 2020 assistant commissioner, added that the census was crucial to

identify the multicultural population, as it would serve as a basis to help communities ensure equal opportunities and determine the need for certain government programmes.

"We need to know the number of children who will need education. It will also help the Government to plan on scholarships and design relevant courses for the future of the nation.

"It will help in identifying new sectors that will provide job opportunities in line with improved technology," he added.

Fadzli said the e-Census kicked off on July 7 this year and would end on Sept 30, while the face-to-face interview by enumerators at households would take place from Oct 7 to 24.

Department of Statistics Malaysia, Selangor branch deputy

director Dipa Chellamuthu urged Klang folk to answer the questions accurately.

"The objective of the census is to compile the profile of the population, households and collect a wide range of demographic and socio-economic characteristics to the smallest area. For the Census 2020 exercise to be a success, people must support by giving correct information," she said.

S'gor to hold career fair in nine districts

It hopes to provide work to nearly 19,000 people who lost their jobs during MCO

THE Selangor Mega Job Fair 2020 and district career carnivals will be held in nine locations across the state starting next month with the aim to address unemployment following the Covid-19 pandemic and movement control order (MCO).

Together with the Human Resources Ministry, JobsMalaysia and Social Security Organisation (Socso), the initiative will offer more than 24,000 jobs to Malaysians.

Selangor Human Capital Development Committee chairman Mohd Khairuddin Othman who

launched the event said as of July 9, the state government had identified 18,976 individuals who had lost their jobs.

"Based on the unemployment rate projections announced by the Prime Minister in June, the state is expecting an unemployment rate of 4.2% for 2020," Khairuddin said at the state secretariat building in Shah Alam.

He said the Selangor government would identify 24,500 job opportunities for its citizens through the job fair and district career carnivals, to bolster the gig economy, as well as implement upskilling and reskilling courses. Sixty-three employers from the

industrial, service and other sectors will participate in the job fair which will be held on Oct 3 and 4 at Shah Alam Convention Centre (SACC).

Khairuddin said the state government would spend RM1.5mil on the initiative and aimed to attract 15,000 visitors to explore up to 5,000 jobs for the event at SACC.

"At the district level, demographics and local market demands will determine the jobs available," he said.

He urged Selangor folk to take full advantage of the job fair and advised those interested to pre-register via JobsMalaysia Selangor

"The carnivals will follow the standard operating procedures approved by the Selangor Task Force on Covid-19 to avoid the spread of the virus.

platforms before attending interviews," said Khairuddin.

The district career carnivals will be held in Kuala Selangor (Oct 10 and 11), Telok Panglima Garang (Oct 24 and 25), Gombak (Nov 7 and 8), Kajang (Nov 14 and 15), Sepang (Nov 21 and 22), Klang (Nov 28 and 29), Hulu Selangor (Dec 5 and 6) and Sabak Bernam (Dec 12 and 13).

High tide fizzles out quickly

Lower than expected water level also leaves authorities puzzled

KLANG: The high tide along Selangor coastal areas which was expected to be damaging has turned out to be a tame affair.

The lower than expected tide level has left authorities puzzled.

Port Klang Fire and Rescue Department operations chief Shahrin Ahmad said the tide appeared to be lower than expected compared to Saturday.

"The water level in houses started rising at 6am and reached within an hour."

"It did not call for any evacuation."

The houses near the riverbanks saw some water seeping in but it was only knee-high and people could actually walk in it and having water up to their ankles.

Kuala Selangor Fire Station chief Ismail Zalaria said the water only rose to his waist.

"There was no damage at all along the coast except for a small stretch. Only a small stretch of the Kuala Selangor main road saw some water seeping in but it was still within a small amount," he said.

Ismail added that he saw some pictures of the tide taken by drones which showed the water level was high.

"I was quite taken aback seeing how high the water level was but it was a different view on the ground," he said.

He said that although the high tide occurrence was only predicted

to take place on Saturday and yesterday, they were still on standby

and ready to respond if needed.

Selangor Disaster Management Unit chief Ahmad Fairuz Mohd said the flooding was limited to areas around Klang and Sabak Bernam.

"It was a different view on the ground," he said.

He said among the areas detected

the water level was slightly higher than the embankment as at 11.30am in

Klang were Sungai Keramat

Kampung Batu 4, Batu 7 (Kampung Kampong Sentosa), Batu 10, Batu 11 and Batu 12 Keningung Sentosa jetty.

Other areas included Kampung Teluk Gong, Kampung Baru, Kampung Sekinchan, Pantai Batu 23, Sungai Halim, Sungai Burung, Sungai Besar, Sungai Burung, Pantai Baru and Sungai Nibong.

"Three houses at Kampung Teluk Gong experienced slight flooding due to an overflow, however, the water

has receded. Embankments at the coast are stable and in good condition and the water is still safe and under control," he said.

In Sabak Bernam, a minor overflow was recorded at Kampung Sungai Sekinchan, Pantai Batu 23, Sungai Halim, Sungai Burung, Sungai Besar, Sungai Burung, Pantai Baru and Sungai Nibong.

"The water level in the area is affected," said Ahmad Fairuz.

IWK denies pollution came from sewage plant

PETALING JAYA: Indah Water Konsortium Sdn Bhd (IWK) has dispelled talk that its sewage treatment plant in Rawang discharged effluent into Sungai Gong, causing the river to turn black on Saturday.

IWK chief executive officer Narendran Maniam said they suspected that illegal waste was disposed near its Rawang Integrated Industrial Park sewage treatment plant and that the waste material had flowed into the plant.

An IWK staff yesterday identified a yellow, non-sewage waste discharged into the plant's inlet

chamber, causing effluent at the final process being contaminated with a deep yellow colour, said Narendran.

"Due to that, IWK stopped the effluent discharge and a cleaning process was carried out and completed on Sunday," he said in a statement yesterday.

The plant in question is an oxidation ditch plant which is connected to 11,106 residents, covering only the industrial area.

IWK also expressed its frustration at often being made "an easy target" for any water pollution inci-

dents without thorough inspections being conducted first.

Narendran was responding to a statement by the Selangor Water Management Authority (Luas) which said that a foamy and coloured effluent from an IWK plant in Rawang was traced in Sungai Gong on Saturday.

"This statement will confuse people and at the same time, point the finger of blame towards IWK when the real cause is probably due to illegal dumping of waste," he said.

He said IWK always ensured the

operation and maintenance work in all 7,000 plants under its supervision were in accordance with the specifications and procedures set by the authorities.

"Sewage treatment plants are only designed to treat wastewater and are not capable of treating any chemicals or other waste that is illegally discharged into the sewer pipeline. Non-sewage waste is often put into sewer chambers by irresponsible parties."

"So, it is better for all parties to work together to address the issue of actual pollution," he said.

"Disposal of non-sewage waste is an offence under the Water Services Industry Act," added Narendran.

On Saturday, Luas confirmed receiving a report on the discolouration of water in Sungai Gong and investigations found there was no smell coming from the water, with the discolouration suspected to have been caused by dyes.

Luas also said that further investigations found the discharge of the foamy and coloured effluent in the river was from an IWK sewage treatment plant in the Rawang industrial area.

Selangor has highest number of dengue hotspots in the country

PETALING JAYA: The authorities have identified 28 dengue hotspots nationwide, with Selangor taking the lead with the highest number of cases.

The highest number of hotspots are in Selangor (19), followed by the Federal Territory of Kuala Lumpur (six), Negri Sembilan (two) and Johor (one).

The bulk of the hotspots in Selangor are located in Hulu Langat

(11 locations), followed by Petaling (eight locations).

Hotspots in the Federal Territory of Kuala Lumpur are in the Titiwangsa, Kepong and Cheras areas.

From January to Sept 20, Malaysia recorded 75,804 dengue cases – with the bulk of the cases (50.5%) in Selangor (38,312), followed by Johor (8,986), and Federal Territories Kuala Lumpur and Putrajaya (8,778).

Perlis recorded the lowest num-

ber of cases (65), followed by Terengganu (328), Kedah (689), Penang (806), and Sarawak (1,351).

Until yesterday, the number of deaths linked to dengue stood at 124.

Selangor recorded the highest number of deaths (36), followed by Johor (32), Sabah (15), Negri Sembilan (eight), Pahang (seven), Federal Territories Kuala Lumpur and Putrajaya (seven), Melaka (six), Kelantan (six), Perak (three), Penang

(two), and Sarawak (two).

According to the Health Ministry, Week 37 saw a 0.8% increase in the number of dengue cases (1,491) compared to the previous week.

The Health Ministry had warned of second wave of dengue cases from June to September, based on the trend recorded over the last five years.

"Take 10 minutes to search and destroy Aedes breeding grounds

inside and outside homes," the ministry advised the public.

The ministry also noted that 165 new dengue cases were recorded on Saturday, and the bulk of the cases were in Selangor (61) and Johor (39).

AIRPORT HAD LONGEST RUNWAY

Subang Airport, officially opened in 1965, replaced the Sungai Besi Airport

BEFORE the Kuala Lumpur International Airport (KLIA) in September welcomed travellers in 1998, Subang International Airport, dubbed Subang Airport back then, had long established itself as the entry point to Malaysia.

Costing a princely sum of RM52 million then, it was built on 535 hectares of land after the government decided in 1960 that the country needed a new airport.

Situated 19km from the capital city of Kuala Lumpur, the airport was officially opened to flights on Aug 30, 1965, by the then Yang di-Pertuan Agong Tuanku Syed Putra ibni Almarhum Syed

Hassan Jamalullail.

The official unveiling ceremony was witnessed by more than 1,500 guests.

The airport also took pride in having the longest runway in Southeast Asia, 3.5km in length and 45m in width, and replaced the Sungai Besi Airport or Semang Airport located in the heart of Kuala Lumpur.

By the 1990s, the airport had three terminals, namely Terminal One for international flights, Terminal Two for Singapore-Kuala Lumpur shuttle flights catering to Singapore Airlines and Malaysia Airlines, and Terminal Three for domestic flights.

In 1996, it was renamed after the then Sultan of Selangor Sultan Salahuddin Abdul Aziz Shah Al-Haj, who was also the 11th Yang di-Pertuan Agong.

By end of 1997, the airport recorded a passenger traffic

growth of 15.8 million. In a report by the New Straits Times in 1998 titled "Goodbye Subang airport, hello KLIA", the airport's first manager, J.D. Desmond Lee, said the airport was "very modern and well-planned" then.

He said that although there wasn't much air traffic then, the momentum grew and by the late 1960s, the airport was bustling with travellers.

In 1980, the expansion of Terminal One began. However, the work initially went rather slowly, much to the annoyance of the then prime minister Datuk Seri (now Tun) Dr Mahathir Mohamad.

To speed things up, he directed that Terminal Two be extended to cope with the entire airport operations, leaving Terminal One completely free for renovation work.

The spanking new Terminal One, covering more than 823 sq m, reopened on June 1, 1983, and was greeted with much excitement.

The newly refurbished terminal featured "ultra-modern" features, namely a baggage trolley conveyor, nose-in parking apron for aircraft, 12 aerobridges, duty-free shops and walkatolators.

By the end of 1997, Subang Airport had handled 15.8 million passengers before its role as the nation's main exit and entry point for air travellers was taken over by KLIA.

Subang Airport continues to be operational on a smaller scale and is currently the hub for Berjaya Air, Malindo Air and Firefly commercial turboprop services. Transmile Air Services is the only other non-passenger non-turboprop aircraft landing there and uses Terminal Two of the airport.

Several notable incidents took place at the airport. In August 1983, a 17-year-old stowaway penetrated security at Terminal Two by hiding himself in a food caterer's lorry.

He sneaked aboard an aircraft parked in a hangar, which subsequently flew to Penang.

He was discovered in the toilet before the aircraft left Penang on a hij flight for Jeddah.

In December the same year,

Malaysia Airlines Flight MH684 from Kuching, with 247 passengers, including 14 crewmembers, crashed into a swamp in Kampung Melaya Subang, 1km from the runway.

Moments after the crash, the aircraft burst into flames, but not before its passengers managed to scramble to safety.

In November 1988, the Air France Concorde landed in Malaysia for the first time. The sleek, delta-winged supersonic aircraft, with 96 passengers and nine crewmembers, was on a chartered world tour.

The Concorde, from Guam, flew at an average speed of more than 1,600kph but decelerated to sub-sonic speeds of below 1,120kph when it entered Malaysian airspace.

In April 1992, a fire broke out in the airport, killing three security guards from the Civil Aviation Department and damaging 29 duty-free shops. The loss was estimated at between RM20 million and RM30 million. The cause of the fire was faulty wiring carried out by unqualified and unregistered electrical contractors.

Six months later, a fire broke out in the control tower, destroying the radar, computers and other equipment worth more than RM2 million.

Former assistant air traffic controller Johari Saaid, 41, was charged with causing the fire and sentenced to 10 years' jail.

IWK not responsible for 'black water' in Sungai Gong

KUALA LUMPUR: Indah Water Consortium Sdn Bhd (IWK) yesterday said the incident of the water in Sungai Gong in Rawang turning black was not due to effluent discharge from the Rawang Integrated Industrial Park sewage treatment plant as reported by the media on Saturday.

IWK chief executive officer Narendran Maniam said the company has identified the presence of non-sewage waste in the plant intake chamber.

"Our staff at the plant are monitoring and controlling the sewage intake. We suspect illegal waste dumping had occurred near our

plant, that caused the substance to flow into the plant.

"We have immediately stopped effluent discharge and started a cleaning operation. Chemical dosing is being carried out to control the situation," he said in a statement yesterday.

On Saturday, it was reported that the Selangor Water Management Board (Luas) received a report that the water in Sungai Gong had turned black but was odourless, and was suspected to have been caused by dyes.

Luas workers found foamy effluent discharge from area near the plant.

Narendran said the matter could confuse the

public and may prompt people to accuse IWK of polluting the river, although the source might have been caused by illegal dumping of waste.

"We are very disappointed for being frequently targeted over any water pollution incident such as this one, without detailed inspections or information," he said, adding that the plant was designed to treat sewage and is unable to deal with chemical or other forms of waste.

He added that illegal dumping of non-sewage waste is an offence under the Water Services Industry Act 2006. – Bernama

IWK denies claims of polluting Sungai Gong

INDAH Water Konsortium Sdn Bhd (IWK) yesterday said the incident of black coloured water found in Sungai Gong, Rawang, was not due to effluent discharge from the Rawang Integrated Industrial Park Sewage Treatment Plant (GBK134) as reported by media yesterday.

Instead, its CEO Narendran Maniam said the company has identified the presence of yellow coloured non-sewage waste inside the plant's intake chamber which caused the final effluent to be polluted with thick yellow colour.

"IWK staff at the plant are still monitoring and controlling the sewage intake into the plant. We suspect that illegal waste dumping had occurred near our plant, which had caused the substance to flow into the plant.

"As such, we have immediately stopped effluent discharge and started a cleaning operation,

expected to be completed today. Chemical dosing is being carried out to control the situation," he said in a statement yesterday.

Yesterday, the media reported that the Selangor Water Management Authority (Luas) received a report on an incident that the water

in Sungai Gong, Rawang, had turned black without the presence of odour, suspected to have been caused by dyes.

On further investigations, Luas found discoloured and foamy effluent discharge, from area 5 IWK GBK 134 plant in Rawang Industrial Park.

Disappointed with the claim, Narendran said the matter could confuse the public besides causing them to accuse IWK, although the real source might have been caused by illegal dumping of waste.

"We are very disappointed for being frequently made an easy target on any water pollution incident such as this one, without detailed inspection or reporting the information completely," he said, adding that the sewage treatment plant was designed to treat sewage and is unable to treat chemical or other forms of waste.

He added that illegal dumping of non-sewage waste is an offence under the Water Services Industry Act 2006. — Bernama
